#### **Father James Ragnoni Scholarship**

Registered Catholic families of St. Anthony of Padua, Blessed Trinity or other parishes may contact the St. Anthony of Padua parish office to apply for the Father James Ragnoni Scholarship. Part of the application process to the parishes requires the filing of a FACTS application. Scholarship awards are determined by the parish.

#### **Aftercare Program**

St. Anthony of Padua School Aftercare charges for 2021-2022 will be \$3.60 per child, per hour. Aftercare runs from 2:45 pm to 5:45 pm on school days. Participation in the program requires that charges remain current at all times based on the agreed payment schedule.

#### **FACTS Grant & Aid Assessment**

Families applying for financial aid need to complete an application and submit the necessary supporting documentation to FACTS Grant & Aid Assessment by March 15 (Round 1) or June 1 (Round 2). Applicants can apply online by at [online.factsmgt.com/aid](https://online.factsmgt.com/aid)

Once an online application has been completed, the following information will need to be sent to FACTS to complete the application process: your most recent Federal tax forms, including supporting tax schedules; your 2020 W-2 for you and your spouse; supporting documentation for Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and TANF. All supporting documents can be uploaded in pdf format online. Documents can also be faxed to 866-315-924 or mailed to FACTS Grant & Aid Assessment, P.O. Box 82524, Lincoln, NE 68501-2524. Please be sure to include the applicant ID on all faxed or mailed correspondence.

- Copies of your 2020 W-2 forms for both you and your spouse.
- Copies of supporting documentation for Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, and TANF.
